## **Upgrades to Washington Township Center Announced**

The Washington Township Board has been actively discussing and planning many updates for the Washington Township Center. The center, which was dedicated in 2002, recently had all the lighting fixtures converted to energy efficient LED technology. The Board utilized a ComEd rebate program, which offered a 40% rebate for the purchase of the lights and the total cost was approximately \$3800. The Road District is also converting all the lighting in their building at a cost of \$2600.

At the October meeting, the Board voted to replace the landscaping in front of the center. The majority of the original landscaping will be removed, and new vegetation will be planted along with adding mulch. The project was completed on October 10th. Also, a new 77" "smart" TV has been purchased for the Meeting Room to replace an aging projection system that is becoming difficult to find parts for. The new TV will easily connect to newer technology and will be used for Senior Movie nights as well as other presentations. The TV is approximately the same size as the old projection setup and will be tied into the current sound system.

Finally, the township has purchased a "Washington Township" flag, which features the township logo. The flag is being displayed in the Meeting Room and another flag will soon be flying outside under the US flag.


### From Assessor Pat Peters...

If you are a homeowner, senior citizen, veteran, disabled veteran, or disabled person, you might be eligible for a money-saving exemption. The Supervisor of Assessments is responsible for administering the following exemptions:

- General Homestead Exemption
- Senior Citizens' Homestead Exemption
- Senior Citizens' Assessment Freeze Exemption
- Disabled Persons' Homestead Exemption
- Disabled Veterans' Homestead Exemption
- Returning Veterans' Homestead Exemption

If you think you are missing an exemption to which you are entitled, please contact Assessor Pat Peters or the Supervisor of Assessments Office.

An explanation of all the available exemptions are listed below. Please contact Assessor Pat Peters if you have questions or think you may qualify for any of the listed exemptions!



Please review the left-hand column of your tax bill to check if you are receiving your exemptions!

### **General Homestead Exemption**

Homestead property (residential property that is occupied by its owner as his/her principal dwelling place) is entitled to an annual homestead exemption of **\$6,000** off the assessed value. If your tax bill is missing the General Homestead Exemption, please contact your local Township Assessor.

### Senior Citizen Homestead Exemption (PTAX-324)

The Senior's Homestead property is entitled to an annual exemption of \$5,000 off the assessed value. This is in addition to the General Homestead Exemption and any other applicable exemptions. To qualify, you must be 65 years of age or older during the assessment year, own or have legal or equitable interest in the property occupied as your principal residence during the assessment year, and be liable for payment of the property taxes. To file for a Senior Citizens Homestead Exemption you need:

- A copy of your Illinois drivers license **OR** Illinois State ID **OR** birth certificate
- A copy of your current Tax Bill **OR** your P.I.N. (property index number)

### Disabled Persons' Homestead Exemption (PTAX-343)

The Disabled Persons' Homestead Exemption is entitled to an annual exemption of \$2,000 off the assessed value. This is in addition to the General Homestead Exemption and any other applicable exemptions. To qualify, you must be disabled or become disabled during the assessment year, own or have legal or equitable interest in the property or a lease-hold interest of a single-family residence, occupy the property as your principal place of residence on January 1st of the assessment year, and be liable for payment of the property taxes. Check with the Assessor's Office for eligibility requirements.

### Senior Citizens Assessment Freeze Homestead Exemption (PTAX-340)

Allows qualified senior citizens to have their home's equalized assessed value (EAV) "frozen" at the base year value and prevents increases due to inflation. (The tax rate is not frozen.) This exemption would be in addition to the General Homestead Exemption and any other applicable exemptions. To qualify for the 2022 tax year (payable in 2023) you must be 65 or older in 2022; your total household income in 2021 was \$65,000 or less and on January 1, 2021 and January 1, 2022 you used the property as your principal place of residence; you own or have legal or equitable interest in the property or a leasehold interest in the property used as a single-family residence; and you are liable for the payment of property taxes. You do not qualify for this exemption if your property is assessed under the mobile home privilege tax. To file for a Senior Citizens Assessment Freeze Homestead Exemption you will need to use the front page of your 2021 IRS 1040 and your 2021 Social Security 1099 while completing the application. If you did not file a 2021 IRS 1040, use the 2021 Social Security 1099 and ALL other household income verification for 2021.

### Disabled Veterans' Homestead Exemption (PTAX-342)

Provides an annual reduction in the equalized assessed value (EAV) of the primary residence occupied by a disabled veteran on January 1st of the assessment year or on a prorated basis during the time of occupancy for the assessment year. This is in addition to the General Homestead Exemption and any other applicable exemptions. A veteran with 70% -100% service connected disability will receive an annual decrease in their assessed value to Zero (0), when the EAV is \$250,000 or less. A veteran with 50%-60% service connected disability will receive an annual \$5,000 reduction off the assessed value. A Veteran with 30%-40% service connected disability will receive an annual \$2,500 reduction off the assessed value. To qualify you must be an Illinois resident who has served as a member of U.S. Armed Forces on active duty or state active duty, Illinois National Guard, or U.S. Reserve Forces, and not dishonorably discharged. Check with the Assessor's Office for eligibility requirements.

### Returning Veterans' Homestead Exemption (PTAX-341)

The Returning Veteran's Homestead Exemption provides a \$5,000 reduction off the assessed value of the veteran's principal residence for two consecutive assessment (tax) years, the tax year and the following year that the veteran returns from active duty in an armed conflict involving the armed forces of the United States. The veteran must own and occupy the property as his or her principal residence on January 1 of each assessment year. This is in addition to the General Homestead Exemption and any other applicable exemptions. Check with the Assessor's Office for eligibility requirements.

## Important Safety Information from Beecher Fire Department Chief Joe Falaschetti Jr.

### Carbon Monoxide (CO) Detectors Can Save Your Life!

Carbon Monoxide, also referred to as CO, is an odorless, colorless, and tasteless gas. It is produced when any fossil fuel, such as; propane, natural gas, coal, oil, or gasoline is burned, and a buildup is caused by an insufficient oxygen supply. Overexposure to CO can cause CO poisoning, which can lead to serious illness, even death.

As of January 1, 2007, CO detectors are required to be installed within 15 feet of all sleeping rooms of all dwelling units. This may require multiple detectors for your home or apartment. This applies to single-family homes, duplexes, townhouses, apartments, hotels, and motels.

### **Types**

There are various types of detectors that can be used: battery powered, plug-in with battery backup, and direct-wired in the building electric system with battery back-up. There are some combination smoke detectors that may be used. Please consult the product literature or manufacturer for compatibility with existing detectors.

#### Installation

The homeowner is responsible for the installation of the detector. If you occupy a rental unit, the installation is the landlord's responsibility. The state of Illinois Public Act 094-0741 requires that CO detectors be installed and there are penalties in the act for noncompliance. A copy of the act is available on the Illinois General Assembly. If you have questions or need assistance we are happy to help, just contact us.

### **Placement**


Place detectors nearest to bedrooms as possible since you are most vulnerable to CO poisoning while sleeping. If your bedrooms are in different parts of the house, place separate detectors near each bedroom area.

#### React

Take immediate action if your CO detector sounds or if you have headaches, fatigue, dizziness, shortness of breath, nausea, and/or confusion. Get fresh air immediately. Call 911 and make sure everyone moves outdoors into fresh air. Do not reenter the building until the fire department has inspected the building and its declared safe.

# Beecher Fire Protection District Providing Smoke Alarms and Fire Prevention Education Through "Be Alarmed"! Program

The Beecher Fire Protection District is working cooperatively with the nonprofit Illinois Fire Safety Alliance and Office of the State Fire Marshall to provide no-cost smoke alarms to residents of Beecher. The Be Alarmed! Smoke Alarm Installation program provides smoke alarms and fire prevention materials to Illinois fire departments in an effort to both educate residents on fire safety as well as to provide them with life-saving devices in their home.

The program was developed to educate residents on the dangers of fire, how to prevent fire from occurring in the home, and to ensure there are working smoke alarms properly installed in homes. By utilizing 10-year concealed battery smoke alarms, it ensures that the power source cannot be removed from the unit and, if properly maintained, will last the life of the device.

"Smoke alarms are the most effective early warming device there is," says Fire Chief Joe Falaschetti. By merely having a working smoke alarm in your home, it reduced your chance of dying in a reported fire by half.

Our goal is to make sure residents have the protection of a smoke alarm, says Chief Falaschetti. Because smoke alarms alone won't prevent every fire death our program includes educating residents on how to create a home fire escape plan, so they know what to do if their smoke alarm sounds.

## Its Harvest Season - Safety Tips for Sharing the Road with Our Farming Community

Washington Township is an agricultural township with hundreds of farms within our boundaries. We thank our farmers for all they do to feed our nation and ask everyone to use caution during the harvest season. Farming equipment has become much larger over the years and according to the National Safety Council, approximately 33% of fatal tractor accidents occur on public roads. In order to decrease the chance of a collision, motorists should follow these six rules of the road:

- 1. Slow down when you see a piece of agricultural equipment.
- 2. Watch for Slow-Moving-Vehicle (SMV) signs.
- 3. Watch for hand signals.
- 4. Pass farm equipment cautiously.
- 5. Watch for flashing amber lights.
- 6. Remember that agricultural operators have a right to drive their equipment on the road and during harvest season, are sometimes out late at NIGHT!

Please be alert and exercise patience when driving near or passing farm equipment on the roadway. Help us to make this year's harvest season a safe one!
