# Official Proceedings of the Washington Township Board of Trustees October 4, 2021 Washington Township Center 30200 Town Center Road, Beecher, IL

Supervisor Stanula was attending a Will County Executive group meeting to Represent District 1 regarding the redistricting plan for Will County. In his absence, Trustee Heldt chaired the meeting.

Trustee Tracy Heldt called the meeting to order at 7:00 p.m. to pay bills for the month of <u>September</u> and transact any other business that may come before the Board of Trustees. The meeting agenda and guest sign-in sheet are attached. Trustee Heldt led the Pledge of Allegiance.

# Approval of the Board of Trustees Meeting Minutes Dated September 9, 2021:

Trustee Heldt asked if there were any corrections or additions to the September 9, 2021, Board meeting minutes as presented. Being none, Heldt asked for a motion to approve the minutes.

## Motion:

Trustee Herlitz made a motion to approve the minutes of the September 9, 2021, Board meeting as presented. Trustee Peterson seconded the motion. There was no discussion on the motion and the motion was unanimously approved by voice vote.

# **Public Commentary:**

Township resident Beverly DeHaan, who lives on South State Line Road, addressed the Board regarding speeding traffic and grass cutting on State Line Road. Mrs. DeHaan explained that the roadside grass is so high it was difficult to see traffic when pulling out of her driveway and at intersections along State Line Road and asked how to get the roadsides cut. She also said people ignore the speed limit (30 MPH) through that area and she is concerned about her own safety, as well as the safety of her neighbors.

Commissioner Smith explained the road maintenance and ditch cutting on State Line Road is split between Washington Township and Lake County, Indiana. Washington Township is responsible for maintenance of State Line south of Indiana Avenue and Lake County takes care of the road north of Indiana Avenue. Smith also explained that traffic enforcement is also split north and south of Indiana between the Will County Sherriff and the Lake County Sherriff. Smith said he would contact Lake County to express her concerns and recommended that Mrs. DeHaan and her neighbors also contact the Lake County Highway Department and Lake County Sherriff's Office.

# Reports:

- Road Commissioner Commissioner Smith reviewed his written report (attached). There were
  no comments or questions regarding his report. Smith added that the Village of Beecher is
  considering pulling out of the joint fuel agreement with the Township, Beecher Fire District, and
  Beecher School District. He said there was a meeting scheduled for later in the week and he
  would report back once he had more information.
- 2. <u>Assessor</u> Assessor Tamez reviewed her written report (attached). There were no comments or questions regarding her report.
- 3. <u>Clerk</u> No report.
- 4. <u>Supervisor's Report</u> Trustee Heldt read Supervisor Stanula's written report. There was no discussion regarding his report.
- 5. <u>Trustees Report</u> No reports.
- 6. <u>Transportation Report</u> There were no riders on the Township's Dial-A-Ride service in September. Will Ride did not submit an invoice in September.
- 7. <u>General Assistance Report</u> There were no new applications or disbursements from the General Assistance fund in September.
